

Distribution of part of the reserve LAW 3943/2011 article 14, LAW 4172/2013 article 48, in conjunction with POL 1007/2014 and POL 1039/2013 according to the decision of the General Meeting.

Space Hellas S.A. hereby announces that the Annual Ordinary General Meeting of the Company's shareholders dated May 24th, 2019 approved the distribution of part of the reserve of the amount 387,391.80 Euros, i.e. 0.06 Euros per share.

From the gross amount mentioned above a 10% tax will be withheld pursuant to article 65 of law 4603/2019. Therefore shareholders will receive the net amount of euros 0.054 per share.

Company's shareholders registered in the electronic files of the Dematerialized Securities System (DSS) dated Friday July 5th, 2019 (record date) for Space Hellas S.A. are entitled to the above distribution. As of Thursday July 4th, 2019 the shares will be traded without the distribution right.

The payment to the beneficiary shareholders will be effected through the payee bank - Alpha Bank S.A. - on Wednesday July 10th, 2019 as follows:

1. Through the Dematerialized Securities System (DSS) Operators, that is Banks and Securities firms, for those shareholders who have authorized their Operator(s) for the collection.
2. By direct credit to the bank account corresponding to the International Bank Account Number (IBAN) declared by the shareholder, pursuant to article 13 of the DSS Operation Regulation and the decision number 6 of the ATHEXCSD Board, as in force, for those shareholders that do not wish to collect the distribution through his/her Operator(s). This case concerns only the shareholders who have declared an IBAN kept with the payee bank – ALPHA BANK S.A.
3. For the remaining shareholders, not credited by their DSS Operator(s), for whatever reason, the collection of the abovementioned distribution will be effected at any branch of the payee bank – ALPHA BANK S.A. from Wednesday July 10th, 2019. In order the above payment to be made, each shareholder must provide the DDS account information and his / her Identification Card. The payment to a third party can be made only to a legally authorized representative of the shareholder's by presenting to the payee bank – Alpha Bank S.A. – an authorization letter with the full details of the beneficiary shareholder as well as the authorized person (first and last name, father's name, Identification Card Number and V.A.T. number) legalized for the originality of the signature of the shareholder by a Police or other Authority.

The above collection of the amount is possible through the payee bank – ALPHA BANK S.A. until July 31st 2020.

After that date, the collection will be made from the company's registered offices: 312 Messogion Ave., Ag. Paraskevi 15341, with the display of the Identification Card and the number of K.A.M.E. either in person or to the legally authorized representative of the shareholders, until the 31st of December 2024, which means until the prescription period of five (5) years after the end of the year in which the claim has been born (article 250 no 15 of the Greek Civil Code).

Amounts not collected until December 31st, 2024 will be written off in favor of the Hellenic State, according to the article 1 of the LAW DECREE 1195/1942.
